Step-By-Step Rejoiner Guidance

Checklist

1. Login into the UNGC [Dashboard](#) portal with your username and password
 - a. If you do not have an existing UNGC login credential, request one here: [Add New Contact](#).
2. Click the “Rejoin the Global Compact” button on the top right corner.
3. Complete the Letter of Recommitment section:
 - a. Input description for reasons for delisting
 - b. Sign the letter of commitment
4. Update the company information:
 - a. General information: # of employees
 - b. Annual gross revenue/sales (USD) or (EUR) (For Spain,Italy & France)
5. Upload your Communication on Progress(CoP) or Sustainability report
6. Submit Rejoining Request and receive a Confirmation email
7. Once the Rejoining Request has been received, participants will be asked to pay any outstanding fees.




